1	Improvements in the questionnaires <i>earSymptoms</i> and <i>earache</i>
	Improvements have been made in the questionnaires <i>earSymptoms</i> and <i>earache</i> to better align with RGS:
	<ul> <li>The alternative "bluish swelling on the outer ear" can now be chosen also when you have had ear trauma, which was not the case before.</li> <li>The alternative "blue-red lump on the earlobe" can now be chosen as a stand-alone symptom and now also has its own exit with the urgency level "Planned" according to RGS.</li> </ul>
	The changes apply directly upon release for all customers, except for those with partner-specific questionnaires.
