	It is now possible to customize start page items and content pages in the Patient app based on whether the patient is enrolled in a care plan or not.
	The personalization engine already supports customization based on age, gender, children and care unit opening hours. Care plan is the newest addition to our available personalization options.
	In the image below, you can see an example of a notification banner which is only shown on the start page if a patient is enrolled in a care plan.







Medical content populating the Triage product

The changes apply directly upon release for all customers, except for those with partner-specific questionnaires.



2	Changes in the questionnaire <i>constipation</i>		
	Changes have been made to the questionnaire <i>constipation</i> to reduce the risk of over-triage in those cases where patients have mild pain together with constipation.		
3	Improvements to the questionnaire <i>libraryAirwaysBreathing</i>		
	Improvements have been made to the questionnaire <i>libraryAirwaysBreathing</i> , due to that earlier there was a potential ambiguity in self-assessed breathing problems.		
	The question about breathing problems is now extended with further options that can be seen in the second image below. Regardless of which breathing intensity you affirm, the right exit is now reached depending on in which activity the problems occur.		
	The images are collected from the search term "breathing problems" but the questions look the same anywhere the questionnaire <i>libraryAirwaysBreathing</i> is included.
